The Management of Loknete Dr. Balasahab Vikhe Patil (Padma Bhushan Awardee) Pravara Rural Education Society is pleased to inform you that you have been appointed as Senior Professor at Pravara Rural College of Pharmacy Loni, Tal-Rahata, Dist-Ahmednagar w.e.f. 25/03/2022, on the following terms and conditions that:-

01. Your appointment shall be on full time basis beginning from date of joining on probation for a period of one year.
02. You will be paid initial basic of Rs.1, 50,000/- p.m.
03. Your appointment is subject to the approval of the Savitribai Phule Pune University Pune and concerned authorities.
04. You shall be provided housing accommodation in the campus as per PRES rules.
05. You shall be provided one mobile SIM Card.
06. Mess food will be available on payment basis all the pharmacy units of PRES.
07. You will ensure that the activities of Pravara Rural College of Pharmacy Loni Unit is carried out smoothly as per schedule and maintaining discipline.
08. If you intend to leave service before completion of one year (12 months) you will have to give one month notice or one month gross salary in lieu of notice period. If you intend to leave after completion of one year (12 months) you will have to give three months' notice or three months gross salary in lieu of notice period. 

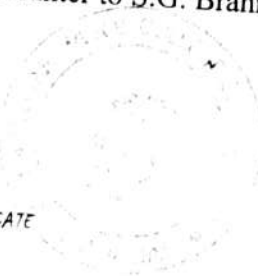



1	<p>Policy for Minor/Major Research projects: The P.I should be allocated 100% of the funds received in order to promote good research work. The responsibility of the audit shall be of the P.I/Principal. The equipments/chemicals purchased out of the project shall be handed over to the college post project and a receipt of the same shall be made by the principal of the institution.</p>
2	<p>Policy for seminar/conference grants: The institution shall be given the liberty to utilize 100% of the funds allocated for seminar/conference with prior permission of higher authorities by presenting the detailed break up of the same. Any additional expense incurred shall be arranged for by the institution through advertisements/sponsors etc. PRES shall not provide for any financial assistance unless and until recommended by the management.</p>
3	<p>Policy for attending seminar/conference within pravara: In order to foster research, attendance of 02 staff of each institution of pravara has been made mandatory for seminars/conferences/workshops which are held at sister concerns. The registration cost of the same would be borne by the respective institutions. In the event of non relevant subjects, a special request can be made to director-research who may then permit. Any staff who has been deputed and if found absent for the event, shall be marked as absent and shall be served with a memo.</p>
4	<p>Special leave rules: The teacher attending National/International Conference/Seminar/ Workshop, any other non-remunerative official business of the PRES constituent Colleges/Institutions/University/UGC/State/Central Government or any other Central or State Government bodies, professional associations located in India and examinations work of PRES/ its colleges and other Universities shall be treated on duty, if the work is within campus and on special leave if the work/Conference/Workshop/Seminar etc. is outside the PRES. The teacher shall be entitled for special leave not exceeding 15 days in a calendar year for the purposes and reasons mentioned above and 5 days for any other affiliating University related work. And in case of College of Agriculture, College of Biotechnology and College of Agricultural Business Management 27 days in a calendar year. Sleeper including Reservation Charges and other teachers shall be eligible to travel by second sleeper once for International/National level within in India and once for state level in a year.
